

Release Notes 7.4 (May 2019)



Trip Management

Enhancements:

1. In the travel activity export, the purpose of the trip is now displayed

Bug Fixes:

1. Display issues on the message for “Delete Confirmation” now fixed
2. Bug enabling users the ability to edit trip reports for completed and cancelled trips is now fixed
3. Display and non-edit issues in the reports tab preventing users from completing trips have now been fixed
4. Bug enabling users the ability to edit start and end dates of a trip that has been completed is now fixed
5. Incorrect file type issues when uploading a document where file type was not selected is now fixed
6. Display issues when action point box in Trip Management module is extended and the related task drop down are now fixed



Action Points

Enhancements:

1. Action point exports now display the reference numbers as links to the actual action links to the action point in the module



Partnership Management

Enhancements:

1. Module now reflects the feature to receive multiple attachments sent from PRP
2. PD Submission Date is now a mandatory field to transition the PD to *Signed* status
3. Left side navigation options are now available to use while users are waiting for data to load
4. Dates will be displayed from DD/MM/YYYY format to display the full date (e.g. 1 April 2019) to eliminate confusion based on the standard use for displaying dates in different countries
5. Supply only Programme Documents can now be closed despite the outstanding .01 DCT that was raised (due to the need to create an FR .01 that was raised when creating the PD)

Bug Fixes:

1. Display errors related to the backdrop when scrolling are now fixed
2. Missing PMP icon display errors are now fixed
3. Filtering in the for a Partner *Agreements* section is now fixed
4. Spelling error in the message while adding a PD/SSFA amendment is now fixed

5. Inactive desegregations are no longer displayed for selection in the performance indicator in CP output
6. Issues displaying the date for last micro-assessment are now fixed
7. Display issues on the field that has "Cluster PD/SSFA Contributes To" are now fixed
8. Typo in CP output ram indicators dialog title is now fixed
9. Drop down display options for "Document Type" when adding attachments is now fixed
10. Display issues on document library section showing signed agreements, duplicating documents and other documents icon are now fixed
11. Errors in exporting indicators (PDF and XLS formats) from reports are now fixed
12. Decimal point display errors when calculating indicator progress of a PD are now fixed



Financial Assurance

Enhancements:

1. Date when spot checks and audits are counted on the HACT status dashboard is based on the date the draft report was submitted to the IP

Bug fixes:

1. Loading errors when uploading attachments before creating an engagement is now fixed
2. Error when trying to finalize a micro-assessment is now been fixed.
3. Error when trying to save a micro-assessment following the completion of fields is now fixed
4. Inconsistency in displaying the micro-assessment cards/sections in specific workspaces have now been fixed
5. Extra blank row display issues when sharing documents are now fixed

1. Office is now included as a column as part of the TPM exports
2. Validation message when adding an existing e-mail in TPM contacts has changed
