Enhancements:

Bug fix:

- 3. Scrolling error between search scroll and page scroll now fixed
- 4. Display error that omits the filter when moving between between a filtered engagement list and an engagement now fixed
- 5. Scrolling display error when selecting options from a drop in the questionnaires at the end of the page now fixed

Partnership Management

Enhancements:

- 1. The following PSEA related fields have been added to the partner details
 - PSEA Assessment Date
 - SEA Risk Rating
- 2. When terminating a partnership, users will now be required to add the termination notice to the partner which will be available to download later
- 3. PCA Generator ignores the inactive partner users even if they are selected

- 4. Previous "Risk Rating" label now re-named to "HACT Risk Rating"
- 5. PSEA risk rating added to partner overview, lists, and assurance tab
- 6. When progress exceeds established thresholds in in PD/SSFA, the percentage now shows the percentages above 100% while the progress bar remains filled
- 7. Validation preventing the selection of the same date for multiple special reports added in the system
- 8. Shortname sync from VISION now appears for all partners
- 9. Narrative progress details in the "Other Info" tab for Special Reports and Humanitarian Reports display "N/A" as this information is not completed by the partner for these types of reports
